One View of the Internet




Introducing Prometheus!

- Prometheus is our new stereotype (label)
- Greek mythology: he stole fire from the Gods and gave it to mankind





Introducing the Olympians!



- The Olympians are our opposite stereotype (label)
- Greek mythology: the Gods
 on Mount Olympus



Promethean views (1)

- The Internet is empowering:
 - "Users", not "consumers"
 - Creativity, innovation
- The Internet is a simple network:
 - Intelligence added by users at the network edges, not be network provider in the core
 - Permits new services "without permission"





Promethean views (2)

The Internet is not tangible:

- It is not a thing, just a *technology*
- It does not act, users do
- It is not responsible, users are





Olympian views (1)

- The Internet was experimental, but is now essential
- The Internet is good, but also does much harm



- The Internet was wild, but must now conform, so that good may flourish and harm may be suppressed
- A regulated Internet as part of a regulated society




Olympian View (2)

- If necessary, technology must adapt to accept regulation
- The technology to protect may not yet be perfect (it never is), but it should be developed and deployed progressively.

– "We must do what we can"

 Network providers must accept their responsibilities as well as the benefits





Promethean Characteristics & Views

- Optimistic about social benefits of technology
- Pessimistic about political action
- Believe Olympians don't understand technology or how technological progress works
 - In particular, believe Olympians do not consider opportunity cost of regulation



Olympian Characteristics & Views

- Olympians believe Prometheans are:
 - politically naïve
 - Irresponsibly blasé about harm caused by introducing technology





Olympian Characteristics & Views

- Olympians believe:
 - *Everybody* must conform to political reality
 - Legitimate government interest *must* be respected
 - Companies and individuals
 are susceptible to regulation



 Everything doesn't have to be done at once; they can work progressively



Summary

For those that want progressive control, regulation doesn't have to achieve its policy goals overnight





Those that value the innovation, creativity & freedom the Internet offers above all, need to recognise that others value security and prefer to protect what already exists



Conclusion

- If we want the regulatory environment to reflect our world view, we need to persuade people to *hold* our world view
- This means engaging in discussion not just about the detail of particular regulations, but

also the *fundamental values* the regulatory environment should support
